

RG6: Mapping a 'Typical' Healthcare Journey on Kidney Transplantation for Adult Indigenous Australian Renal Patients in South Australia

Background

- High rates of End-Stage Renal Disease (Stage 5 of renal failure) and low rates of gaining eligibility for kidney transplantation for Indigenous Australians as compared to non-Indigenous Australians.^{1,2}
- The kidney transplantation is a recognised treatment for most renal failure patients with from either a living or a deceased donor.³
- Many Indigenous Australians are unfamiliar with the transplantation work-up process; therefore, it is vital to map out a clear pathway of the steps and requirements for kidney transplantation.

Aims

- To map a 'typical' journey undertaken by an Indigenous Australian adult living with kidney failure in SA who wishes to become eligible for kidney transplantation.
- To assist the AKtion project in better understanding and improving communication, collaboration, planning, and cultural aspects of Indigenous Australian patient journeys.

Methods

Qualitative Methodology

- 3 stages with the utilisation of Participatory action research (PAR) approach: (1) Look and Listen, (2) Think and Discuss, and (3) Take Action.
- Dadirri deep listening, Ganma-knowledge sharing, and cultural respect were emphasised throughout the research.^{4,5,6}



1. Identifying Problems

- Look and Listen
- Review relevant health publications and websites and clinical guidelines



2. Reviewing Solutions & Strategies

- Think and Discuss
- Validation by clinical experts and patient journey experts (AKtion reference group members)



3. Improving Patient Journeys

- Take action
- Finalising and sharing the information on kidney transplantation journey mapping

Figure 1: The 3 stages undertaken to create the health mapping journey for kidney transplantation.

Results

- The only kidney transplantation service in South Australia is located at The Royal Adelaide Hospital.⁷
- Patient assisted travel schemes (PATS) is available to assist with transportation and relocation purposes but is limited.⁷
- Accommodations are available for patients who live 100km from Adelaide or for clinical appointments through the Kangawodli services.⁸

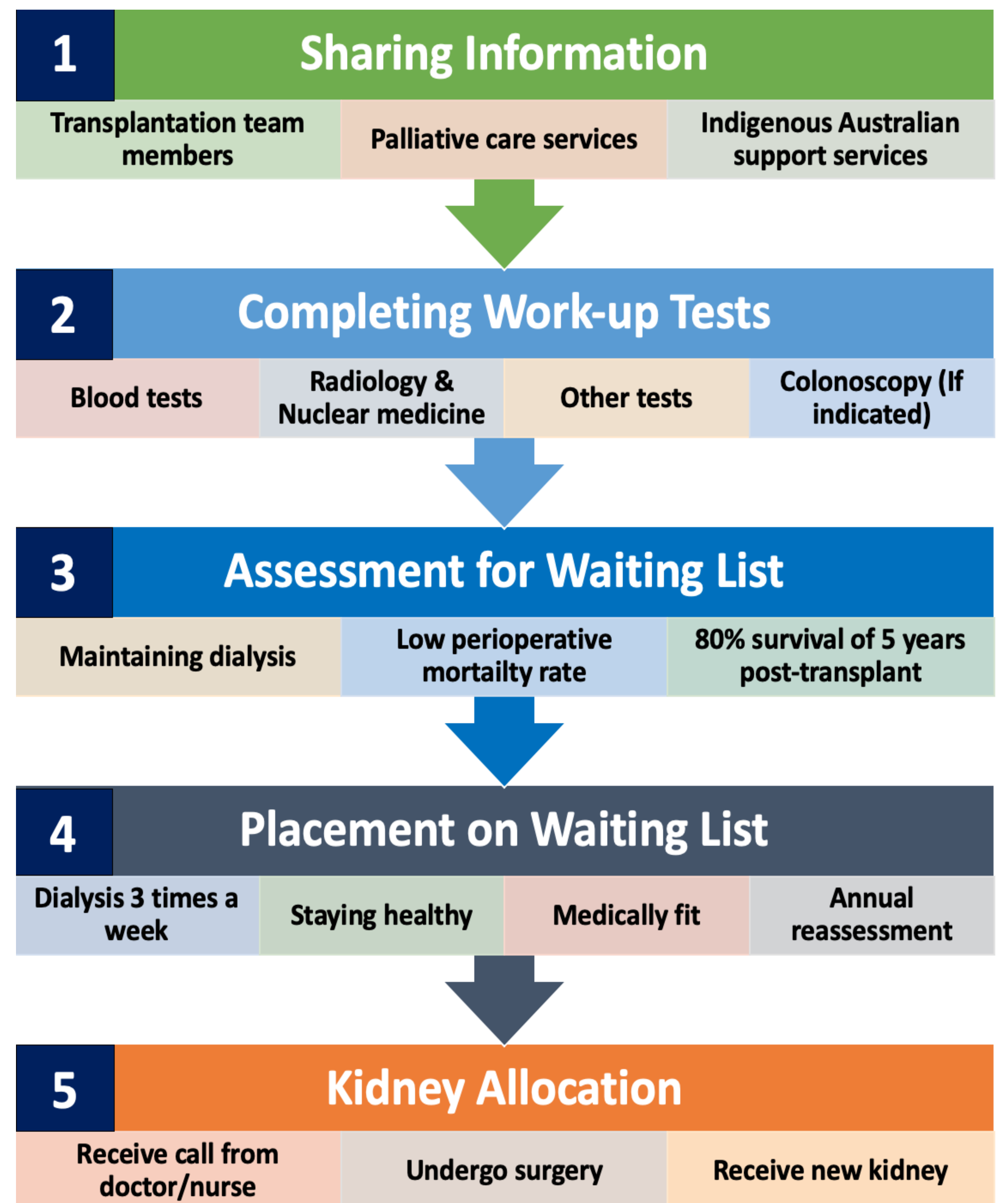


Figure 2: The 5 crucial steps of receiving kidney transplantation.⁷

Conclusions

- The eligibility of getting kidney transplantation by Indigenous Australians require 5 crucial steps, multiple work-ups and assessments.
- Indigenous Australians often experience difficulties when trying to navigate the confusing kidney transplantation journey.
- Significance: This study could increase awareness of kidney transplantation processes and inform future mapping.
- Limitation: The study could not include identifiable data due to ethics, therefore only a literature review was conducted.
